### ELECTRICIANS HEALTH AND WELFARE PLAN IBEW 995

This is a summary of the annual report for the ELECTRICIANS HEALTH AND WELFARE PLAN IBEW 995, (Employer Identification No. 72-6029075, Plan No. 501) for the period January 1, 2023 to December 31, 2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The value of plan assets, after subtracting liabilities of the plan, was \$4112959 as of December 31, 2023 compare to \$2587042 as of January 1, 2023. During the plan year the plan experienced an increase in its assets of \$1525917. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$4799584. This income included employer contributions of \$4127886, employee contributions of \$323977 and earnings from investments of \$140418. Plan expenses were \$3273667. These expenses included \$846918 in administrative expenses and \$2426749 in benefits paid to participants and beneficiaries.

#### ADDITIONAL EXPLANATION

The Electricians Health and Welfare Plan IBEW 995 is self-funded for all medical benefit and eligible surviving spouse life insurance benefit claims incurred under the terms of the Plan, and the Board of Trustees for the Plan is committed to pay for all such benefit claims out of the assets of the Electricians Welfare Trust Fund, IBEW 995.

The Board of Trustees of the Plan has contracts with Dearborn Life Insurance Company to pay all other life insurance and accidental death and dismemberment benefits incurred under the terms of the Plan. The total premiums for such contracts for the plan year ending December 31, 2023 were \$36,312 and were paid out of the assets of the Fund.

## PAPERWORK REDUCTION ACT STATEMENT
